#### In this role you will:

- New Product Launches: Engage with Marketing and Product Innovation teams to support new development activities, with emphasis on implementing towards end process via third-party manufacturers and suppliers.
- Interact directly with PD, R&D and Project Management teams to co-facilitate NPD project transition within Operations and Supply Chain teams and help drive progress during the Stage Gate process.
- Oversee on-time product launch deadlines through coordinating product purchasing, production and managing lead times in conjunction with Project Managers and Packaging team.
- Coordinate formula revisions for RSPO and other ingredient changes across Supply Chain and Operations teams, in conjunction with Stage Gate process.
- Facilitate and manage technology transfer with R&D on new product formulas to designated third party manufacturing partners.
- Collaborate cross functionally with internal stakeholders (PD, R&D, Product Marketing, Supply Chain and Packaging) to develop and roll out processes to increase company efficiency.
- Manage RFQ finished goods database to track and record all RFQs issued to third party manufacturing partners and kit assembly suppliers. Conduct cost modeling exercises and analysis towards cost optimization.
- Prepare and process requisitions and purchase orders for materials, pilot/scale up batches and services.
- Responsible for continued evaluation to identify alternative materials to improve product performance, lead times and pricing, etc. Actioning against cost reduction strategies and savings objectives.
- Manage the assembly, standardization and maintenance of Finished Goods specifications.

- At least five years in a well-respected supply chain organization with a track record of results managing direct material and packaging categories.
- Experience in all aspects of product development and commercialization with third party manufacturing partners.
- Strong understanding of lean manufacturing and general supply chain tools for optimization.
